QUALIFICATION:- The candidate should possess a degree of Bachelor of Arts or Science or equivalent thereto from a recognized university. He/she should have passed Matriculation Examination with Hindi as one of the subject.

MODE OF SELECTION:-

Candidates shall have to take a written examination in the following subject:-

No candidate shall be considered for appointment unless he/she obtains 40% marks in aggregate in the written examination and having proficiency in operation of computers (Word and Spread Sheet). The candidates have to qualify Computer Typing Test at the speed of 30 w.p.m.

- AGE LIMIT:- No person shall be recruited to the service if he/she is less than 18 years or is more than 42 years of age as on 05.03.2025, provided that relaxation in upper age limit is admissible to the reserved categories as per instructions of the Hon'ble High Court of Punjab and Haryana and/or Government of Haryana. In the case of candidates belonging to Scheduled Caste and Backward Class-A and B of Haryana State and persons already in Government employment, the upper age limit shall be such as may be fixed by the Government of Haryana from time to time.
- LAST DATE:-Last date for receipt of applications shall be 05.03.2025 upto 05:00 PM. Applications received thereafter shall not be entertained under any circumstances. Delay on the part of postal authorities shall not be a ground for entertaining applications received after due date. Applications received through email shall not be entertained.
- DATE AND PLACE OF TEST:- The information qua date and place of examination/test shall be uploaded on the official website of District Court, Rewari i.e. <u>https://rewari.dcourts.gov.in/notice-category/recruitments/</u> in due course.

However, no separate letter/information in this regard shall be issued to the candidates. The candidates are required to bring their proof of identity at the time of written test/interview, failing which, he/she will not be allowed for test.
